WHAT

- Artists of all media from throughout the world are invited to enter the Zimmy's Dylan Days Art Exhibition.
- Enter work inspired by the life and-or lyrics of singer-songwriter Bob Dylan.

WHERE

- Zimmy's Downtown Bar and Grill, 6th and Howard Street, Hibbing, MN 55746, U.S.A.

WHEN

- May 25-27, 2012, in celebration of Bob Dylan's birthday and the 2012 Dylan Days.

HOW TO ENTER (Entry Requirements)

- Artists 18 years of age and older are welcome to enter.
- Work is limited to one piece per artist.
- All media are welcome (e.g., watercolor, oil, acrylic, gouache, mixed-media, pastel, charcoal, digital, pencil, sculpture, assemblages, collage, etc.)
- Artists may enter to COMPETE FOR CASH PRIZE (1st, 2nd, 3rd) or FOR DISPLAY ONLY (NFS, Not For Sale).
- Entry fee of \$20.00 is required for both competing or display entries (please see entry form, page 2, attached, and pay by check or credit card. No cash, please.)
- Each artist entering the exhibition will receive a commemorative Dylan Days certificate.
- First 50 entrants will receive a \$5.00 Zimmy's Gift Card.
- Work must be shipped to arrive at Zimmy's via parcel post, UPS, or other delivery service, or delivered in person, May 1-21, 2012.
- Work may be marked FOR SALE or NFS (Not For Sale). If work is sold, Artist will receive 100% (one hundred percent) of the sales price.
- All work must be ready for display
 - Framed pieces must feature wires on the back for hanging
 - Assemblages and other work designated for display on Zimmy's wall must feature wires on the back for hanging.
 - Matted and/or Unframed 2-dimensional work will be placed in a bin or display rack for easy viewing.
- If art is shipped, all postage and shipping charges to and from Zimmy's are the responsibility of the artist. Zimmy's will not be responsible for the cost of shipping/ mailing work.
- If work is large or fragile in size or structure, please phone ahead to make arrangements for its display. Phone (218) 262-6145, or 1-866-305-3849 (toll-free) and ask for Linda.
